Whereas, the case was examined in this department and marks/diploma certificates of the above named official were forwarded to the concerned Institution vide this department's letter dated 19.01.2022 for verification/authentication & genuineness of the diploma/marks certificates. In response, the Registrar, Punjab State Board of Technical Education & IT Chandigarh vide their communication No. PSB/Verification/2022/482 dated 22.03.2022 has furnished the genuineness of the Diploma certificate acquired by the above named official.
