Whereas, the case was examined in this department and marks/diploma certificates of the above named official were forwarded to concerned Institution i.e Controller of Examination Government Polytechnic College, Bikram Chowk, Jammu vide this department's letter dated 09.03.2022 for verification/authentication & genuineness of the diploma/marks certificates. In response, the Secretary, J&K Board of Technical Education vide his letter dated BOTE/Verif/22/8495 dated 24.03.2022 has intimated that as per the records the candidate has passed the three year diploma in Civil Engineering.

Whereas, the case was re-examined in the department a notice was issued vide No. PWD/1/2022-05 PWD R&B Deptt dated 19.04.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer PW(R&B) Jammu vide his letter No. CEJ/Estab./S/1472-74 dated 28.11.2022 has intimated that his office has not received any objection from any person till date after issuance/publication of the said notice.

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma certificates acquired by the above named official, treat him as Diploma holder Works Supervisor (Civil) and include his name at appropriate place in the relevant seniority list of Diploma holders Works Supervisor (Civil).
