  - The Technical sanction/administrative approval shall be obtained prior for undertaking the said work from the competent authority.
  - The expenditure shall be incurred strictly as per the guidelines of the scheme and conditions laid down in the sanctioned letter of the concerned Ministry, Govt. of India.
