Whereas, you (Er. Mohan Lal Kundan), then Executive Engineer in PW (R&B) Department Spl. Sub Division Marwah posted during the year 2017-18 are hereby served the following article of charges upon you:

You as Executive Engineer in PWD (R&B) Subdivision Marwah during the year 2017-2018 , without adopting due course of norms executed work in respect of clearance of snow from Margan to Inshan, Inshan to Marwah, Inshan to Basmina and Inshan to Margi (Inshan to Mungli) etc works.

- a. that tender/e-tendering for the year 2017-18 were not floated by you in respect of works of clearance of snow from Margan to Inshan, Inshan to Marwah, Inshan to Basmina and Inshan to Margi (Inshan to Mungli) etc.
- b. That you have not submitted the damage report to the higher authorities for the concerned period before execution of work.

Whereas, being in the capacity of the Executive engineer posted the and being a public servant you have failed to maintain absolute integrity and honesty in the discharge of your official duties, you should have put these above mentioned works to e-tender but you got those works executed departmentally.

Whereas, you being in the capacity of the Executive Engineer ignored the codal formalities to be followed while allotment of the said works and have failed to maintained absolute honesty and integrity in discharge of your official duty.

Whereas, you being the public servant for which you are liable for department action has contemplated under rule 33 of J&K Civil Services (CCA Rules 1956).

No, therefore you are hereby called upon to tender your reply /written statement viz-a—viz aforementioned article of charges within a period of 21 days days failing which further proceedings shall follow.

# Draft statement of imputation in verification No.13/2018

Statement of imputation of misconduct in support of the draft article of charges framed in Verification No.13/2018 against Shri Mohan Lal Kundan then Executive Engineer in PWD(R&B) Spl. Sub Division (PIU) Marwah.

An open verification was initiated on the basis of two written complaints lodged by Sh.Javed Iqbal Ahanger, Contractor (Civil) S/O Ghulam Ahmed R/O Astan Bala Kishtwar against Officers/Officials of PWD (R&B) Special Sub Division (PMGSY, JKRDDA Division, Marwah, which were clubbed being of same nature. It was alleged that the PWD (R&B) Special Sub Division (PMGSY, JKRDDA Division, Marwah department in utter violation of contract laws has executed snow clearance works for the year 2017-18 on exorbitant rates to cause extensive financial loss to the state exchequer and without inviting tender/e-tender and made allotment of the said work to some influential contractors.

After probe into the matter following facts have been emerged :-

- a. That Superintending Engineer PMGSY Circle Batote has released funds to Executive Engineer PMGSY Division Marwah to the tune of Rs. 54.23 Lacs for the works of the snow clearance from Margan to Inshan, Inshan to Marwah, Inshan to Basmina and Inshan to Margi(Inshan to Mungli) etc works but no NIT has been published in respect of the above said works
  - b. That Executive Engineer in PWD(R&B) Spl. Sub Division (PIU) Marwah during the year 2017-18, executed work in respect of clearance of snow from Margan to Inshan, Inshan to Marwah, Inshan to Basmina and Inshan to Margi(Inshan to Mungli) etc. executed work without floating tenders/etenders.
  - c. No damage report was submitted by the then Executive Engineer PWD(R&B). Spl. Sub Division (PIU) Marwah to the higher authorities for the concerned period before the execution of work.

Keeping in view the above facts, that being public servants, he failed to maintain absolute integrity and honesty in the discharge of his official duties which tantamount to unbecoming of a public servant for which he is liable for departmental action as envisaged under Rule 33 of J&K Civil services (CCA). For this act of Shri Mohan Lal Kundan then Executive Engineer in PWD(R&B) Spl. Sub Division (PIU) Marwah a Regular Departmental Action is required to be initiated against him.
