In supersession to the previous Government Order No. 270-PW(R&B) of 2023 dated 26.06.2023 sanction is hereby accorded to the appointment of Er. Ghulam Rasool, Superintendent Engineer PW(R&B) Circle Budgam as Inquiry Officer and Er. Javed Iqbal Shawl, Executive Engineer, PW(R&B) Division Budgam as presenting Officer to enquire into the allegations leveled against the subject.

The enquiry report submitted by the previous Inquiry Officer is enclosed on which the competent authority has observed:

"It needs to be considered that the contractor who was allotted work of just Rs 81,228 was allotted work of Rs 10 lakh i.e more than 12 times of the work allotted work. Original work allotted on tenders is Facelifting to Syed Meerak shah Road from Ashai Bagh bridge to Zakoora Crossing Srinagar by way of painting to Electric Poles/Parapets and road marking at centre and side lines including Zebra Crossing etc." and extension has beengiven as construction of retaining wall along road from Dalkawpora to Chowdary Bagh at Rainawari Srinagar with amount of Rs.1033565. May please re-examine".

The Inquiry Officer shall submit the report/findings to the Administrative Department along with recommendation within 21 days from the date of issuance of this order with specific comments/ recommendations about the above observations of the authorities.


