Whereas, the Chief Engineer, PW(R&B), Jammu vide his letters No.CEJ/ Estab/ S/352-53 dated 26.06.2020 and Noo.CEJ/ Estab./S/ 2775- 77 dated 20.03.2021 has forwarded the case of Mr.Mohd Rabnawaz Khan and Mr.Rameez Khan, Draftsmen (Civil) for acceptance of their Diploma in Civil Engineering and inclusion of their names in the relevant seniority list of Diploma holders Draftsman (Civil). The service particulars of both the Draftsmen (Civil) are given as under:-

Whereas, the case was examined in the department and Diploma/marks certificates of both the above named officials were forwarded to the Punjab State Board of Technical Education and Industrial Training, Chandigarh on 19.02.2021 for verification of genuineness of Diplomas acquired by them. In response, the Registrar of the concerned Board vide his No. PSB/ Verification/2021/847 dated 13.05.2021 has verified the genuineness of the diploma acquired by the above named Draftsmen.

Whereas, the above named incumbents have also produced undertaking affirming therein that "in case any information about their diploma is found fraudulent/bogus at any time during service, the same shall be deemed to be cancelled ab -initio and action as warranted under rules shall be initiated against them in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956".

Whereas, On re-examining of the case in the department, it has been observed that there is a case to accept the Diploma acquired by above named incumbents and include their names at appropriate places in the relevant seniority list



of Diploma holders Draftsman (Civil) as and when the same is notified afresh by the department.

Whereas, the case was further examined and a Notice was issued vide endorsement No. PW(R&B)HRM1/75/2021 dated 22.09.2021 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PW(R&B), Jammu vide his letters dated 19.02.2022 and 28.11.2022 has intimated that his office has not received any objection from any person till date after issuance/ publication of said notice regarding proposed action of the department.

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma in Civil Engineering acquired by the above named official, treat them as Diploma holders Draftsmen (Civil) and include their names at appropriate places in the relevant seniority list of Diploma Holder Draftsman (Civil) as and when the same is notified.

Now therefore, Mr. Mohd Rabnawaz Khan and Mr.Rameez Khan, Draftsmen (Civil) shall henceforth be treated as Diploma holders Draftsmen (Civil) and subsequently their names shall be included at appropriate places in the relevant seniority list of Diploma Holders Draftsman (Civil) as and when the same is notified afresh by the department.
