The DDO Powers are subject to the fulfillment of following conditions.

- The DDO shall operate on the treasury to the extent of funds placed at his disposal by the Competent Authority.
- That all the codal formalities are to be fulfilled while incurring the expenditure.
- That no excess over allotment/irregular expenditure is made by the DDO.
- That the concerned DDO shall ensure submission of the Accounts to the different quarters in time and maintain record as prescribed in General Financial Rules, 2017/Manuals.
- That the DDO shall submit the monthly/quarterly, Receipt/Expenditure statements to the Administrative Department through their controlling officer.
- That the DDO shall also obtain AG's Code from the Accountant General, J&K
