Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 and the General Administration Department's O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Shri Sheikh Tajamul Raja was appointed as Class IV (MT5) vide Government order No. 388-PW(R&B) of 2022 dated 29,10,2022; and

Whereas, vide Government order No. 388-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Shri Sheikh Tajamul Raja, Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Department Kashmir for further posting, and

Whereas, subsequent to his appointment/ joining, the Chief Engineer, PW(R&B) Department Kashmir has informed that Shri Sheikh Tajamul Raja, Road worker through the medium of an application dated 01-07-2023 has tendered his resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, PW(R&B) Department Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate is suffering from Dermalomyositis:

· Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority

a. suspend the probation of a probationer and discharge him from the service for want of

b. at its discretion terminate the probation of a probationer and discharge him from the service.

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Sheikh Tajamul Raja, MTS(Road Worker) is hereby accepted and is discharged from the Government service w.e.f. 01.07.2023 on his own request,
