The appointment of the above candidate shall further be subject to the following conditions:-

The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee has no criminal record and is not facing any

criminal proceedings in any court of law.

The salary of the appointee(s) shall not be drawn and disbursed to him Π. satisfactory report in respect of genuineness of qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.

The appointment of the candidate shall be governed by the "New Pension III.

Scheme" as per SRO-400 of 2009 dated 24-12-2009.

The inter-se-seniority of the appointees shall be determined in accordance IV. with the merit secured by the appointee(s) in the selection list prepared by the Services Selection Board.
