Sanction is hereby accorded to the temporary appointment of Mr. Mohammad Yousuf Kumar, S/o late Abdul Rashid Kumar(Ex-Helper/Road Wroker) R/o Rawalpora, Tehsil Qazibad (Kralgund) District Kupwara, as Road Worker (Class-IV), in the pay Level SL I (14800-47100) in PW(R&B) Department R&B Division Handwara, in District Kupwara, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The post of Helper held by the deceased is also abolished in terms of standing orders, issued by the Government in this behalf.

The appointee shall be on probation for a period of two years, and shall report to Chief Engineer Public Works(R&B) Department, Kashmir within a period of 21 days from the date of issuance of this order. The appointee shall be allowed to join only on the production and verification of the following certificates/documents in original:-

- 1. Academic/qualification certificate
- 2. Date of Birth Certificate
- 3. Permanent Resident Certificate
- 4. Health certificate by officer not below the rank of Chief Medical Officer.
- 5. Dependent Certificate;
- 6. No loan certificate under Self employment Scheme from DIC concerned and employment department; and
- 7. All other relevant documents as are required under SRO-43

In case the appointee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled ab-initio without any further notice.

The appointment shall be subject to the following conditions:-

- c) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from Additional Director General of Police CID Jammu & Kashmir to whom a reference shall be made by the Chief Engineer Public Works(R&B) Kashmir, his appointment shall be itself stand cancelled ab-intio without further notice and he/she have no claim of his appointment.
- d) The testimonials/certificates thus produced by the appointee, shall be got verified from the concerned agencies by Chief Engineer, Public Works (R&B) Department, Kashmir and, if on verification, any of the certificates produced by the appointee is proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received to whom the reference will be made by Chief Engineer Public Works(R&B) Department, Kashmir
