Sanction is hereby accorded to the temporary appointment of Mr. Sohan Lal., S/o late Skinder Lal, (Ex-Gardner Mali) R/o, Village V.P.O. Kangrail, Tehsil Bhalwal District Jammu as Road Worker (Class-IV), in the pay Level SL I (14800-47100) in Public Works (R&B) Department in District Cadre Jammu, in relaxation of the prescribed qualification in terms of Rule-7 under SRO-43 of 1994.

The appointee shall be on probation for a period of two years, and shall report to Chief Engineer Public Works(R&B) Department, Jammu within a period of 21 days from the date of issuance of this order. He shall be allowed to join only on the production and verification of the following certificates/documents in original:-



- 1. Academic/qualification certificate
- 2. Date of Birth Certificate
- 3. Permanent Resident Certificate
- 4. Health certificate by officer not below the rank of Chief Medical Officer.
- 5. Dependent Certificate;
- 6. No loan certificate under Self employment Scheme from DIC concerned and employment department; and
- 7. All other relevant documents as are required under SRO-43

In case the appointee fails to join within the stipulated period of 21 days, his appointment shall stand cancelled ab-initio without any further notice.

The appointment shall be subject to the following conditions:-

- c) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his character and antecedents is received from Additional Director General of Police CID Jammu & Kashmir to whom a reference shall be made by the Chief Engineer, Public Works(R&B) Jammu, his appointment shall itself stand cancelled ab-intio without further notice and he has no claim of his appointment.
- d) The testimonials/certificates thus produced by the appointee, shall be got verified from the concerned agencies by Chief Engineer, Public Works (R&B) Department, Jammu and, if on verification, any of the certificates produced by the appointee is proved fake or forged, the appointment shall be cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of (a) and (b) above is received to whom the reference is made by Chief Engineer Public Works(R&B) Department, Jammu.
