Whereas, Department of Disaster Management Relief, Rehabilitation and Reconstruction has forwarded a copy of order No. 25-SSB of 2020 dated 15.01.2020 of the Services Selection Board issued under endorsement No. SSB/Secy/Sel./2020/413-15 dated 15.01.2020, where under the candidature of Sh. Sawan Dhar S/o Ravi Kumar Dhar (Junior Engineer) figuring at S. No. 20 under open category has been cancelled ab-initio whose selection was previously kept withheld by the Service Selection Board in the select list. Therefore, the DMRR&R has requested for considering the appointment of next eligible candidate as Junior Engineer (Mech) out of the waiting list under Hon'ble Prime Minister's Special Package for Return and Rehabilitation of Kashmiri Migrants to the Kashmir Valley.

Whereas, so far, waiting list for the post of Junior Engineer (Mechanical) has been utilized in respect of only one candidate, namely, Sh. Amit Raina S/o Ashok Kumar Raina R/o H.No.102, Bari Barhamana Sarore, Neher, Kashmir Colony, Indane Gass Plant, 181133, Samba, Kartholi who was figuring at S.No.01 in the waiting list against the vacancy accrued to the non-joining of Sh. Ashwani Kumar Raina S/o Triloki Nath Raina R/o 5/49, Patoli Mangotrain, Near Mast Baba Ashram Jammu. The order in that regard stood issued vide Government Order No. 20-PW(R&B) of 2020 dated. 23.01.2020.

Now therefore, sanction is hereby accorded to the:-

i. Appointment of Sh. Paras Chrungoo S/o Rajender Chrungoo R/o 65-D, Janipur, Dev Vardat, Patoli Mangotrian, Near Mast Ram Jammu, as Junior Engineer (Mechanical), under Prime Ministers Special Package for Return and Rehabilitation of Kashmiri Migrants to the Kashmir Valley. His joining report shall become effective only after he executes an agreement in the "Form" prescribed under Jammu and Kashmir Migrants (Special Drive) Recruitment Rules, 2009 issued under Notification SRO-412 of 2009 dated 30/12/2009.

- ii. The appointee shall be on probation for a period of two years and the Chief Engineer, Mechanical Engineering Department, Kashmir, shall allow the candidate to join only after production & verification of the following documents in original:
 - a. Education/Technical Qualification Certificates/Marks Sheet, which will also include whether technical degree/diploma is approved for employment in the UT of J&K.
 - b. Date of birth certificate/Matriculation Certificate.
 - c. Permanent Resident Certificate/State Subject.
 - d. Migrant Status Certificate issued by the competent authority from Relief and Rehabilitation Commissioner (Migrant).
 - e. Health Certificate issued by an officer not below the rank of Chief Medical Officer.
 - f. Certificate from concerned authorities to the effect the no loan under self employment scheme has been obtained/availed by the candidate.
 - Reserved category certificate if required.
 - h. Any other relevant certificates as are required under rules.

Further the appointment of the candidate shall be provisional and subject to the following conditions:-

- i. In case of receipt of an adverse report about his character and antecedents from CID Organization and on confirmation thereof by the State/Divisional/District Level Screening Committee, as the case may be, the appointment shall automatically stand cancelled without any notice.
 - a. A person convicted by the competent court of an offence involving moral turpitude, heinous offences like murder, rape, dacoity, robbery under offences under NDPS, Act shall be regarded not fit for Government service.
 - b. During the course of verification of qualification, certificates, documents or any other relevant documents on the basis of which the candidates has been appointed turns out to be fake/ fictitious, the appointment shall be deemed to be cancelled abinitio.
 - c. Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K (to whom reference shall be made by the Chief Engineer, MED Kashmir and verification of relevant certificates/documents is received from the concerned authorities.
 - d. The appointment order shall be governed under new pension scheme as per SRO-400 of 2009 dated 24/12/2009.
 - e. The inter-se-seniority of the appointee shall be fixed separately.

- f. The appointment of the candidate as Junior Engineer (Mechanical) shall be subject to the outcome of the writ petition(s), if any, pending in the court of law.
- g. The appointment of the candidate shall be deemed cancelled, if he will not join the duties within 30 days from the date of issuance of appointment order in terms of Circular No.08-JK(GAD) of 2019 dated 04/12/2019.

In case, the appointee migrates from the Kashmir valley at any time during his service tenure, for any reason whatsoever, his appointment / service shall stand terminated without any notice by itself by the act of his migration.
