WHEREAS, the Diploma/marks certificates of the official were forwarded to the Registrar, Punjab State Board of Technical Education & Industrial Training, Chandigarh on 23.03.2021 for verification of genuineness. In response, the Registrar of the said Board vide No. PSB/Verification/2021 /988 dated 09.06.2021 has verified the genuineness of the Diploma acquired by the above named Draftsman.

WHEREAS, the above named incumbent has also produced undertakings in the shape of Affidavit affirming therein "that in case any information about his diploma is found fraudulent/bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

WHEREAS, the case was examined in the department and it has been observed that there is a case to accept the Diploma acquired by above named incumbent and include his name at appropriate place in the relevant seniority list of Draftsman (Civil) diploma holders as and when the same is notified afresh.

WHEREAS, the case was further examined in the department and a notice was issued vide endorsement No.PWD-HRM1/53/2021/05 dated.13.08.2021 for

Inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, R&B Jammu has intimated that no objection from any person has been received regarding proposed action of the department

WHEREAS, the case has been re-examined in the department and it has been decided to accept the Diploma certificate acquired by the above named official, treat him as Diploma holder Draftsman (Civil) and include his name at appropriate place in the relevant seniority list of Diploma Holders Draftsman (Civil) and also exclude his name from the relevant seniority list of Draftsman wherever exists.

NOW, THEREFORE, Mr. Maroof Chowdhary, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma Holders Draftsman (Civil) as and when the same is notified afresh, consequently his name shall be deemed to be deleted from the seniority list of Draftsman.
