Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 and the General Administration Department's O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, Mr. Towkeer Ashraf S/o Mohd Ashraf Shah R/o Khairkoot Banihal, Ramban under RBA Category, Application No. 880931709 & Roll No. 181262161089 was among others, appointed to the post of Road Worker vide Government order No. 323-PW(R&B) of 2021 dated 22.10.2021; and

Whereas, vide Government order No. 323-PW(R&B) of 2021 dated 22.10.2021, among others, the services of Mr. Towkeer Ashraf were placed at the disposal of the Chief Engineer, PW(R&B) Department, Jammu for further posting; and

Whereas, while being posted in the office of the Chief Engineer, PW(R&B) Department, Jammu Mr. Towkeer Ashraf joined Government service on 01.11.2021 and posted in PWD(R&B) Division Ramban vide office order No. CEJ/ADM/320 of 2021 dated 16.11.2021 by the Chief Engineer; and

Whereas, subsequent to his appointment, the Chief Engineer, PW(R&B) Department, Jammu vide letter No. CE/Estab/S/3098-3100 dated 07.02.2022 reported that the official has tendered his resignation in the Public Works (R&B) Department before Executive Engineer, PWD(R&B) Division Ramban on 08.12.2021 on the grounds that he is not willing to work as Road Worker; and

Whereas, the Chief Engineer, PW(R&B) Department, Jammu forwarded his request to the Public Works (R&B) Department for acceptance of his resignation.

Now, the matter has been considered with reference to the rules governing the subject and it has been found that the official is still on probation and has not qualified the prescribed service, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Towkeer Ashraf (Road Worker) S/o Mohd Ashraf Shah R/o Khairkoot Banihal, Ramban under RBA Category is hereby accepted and he is discharged from the service w.e.f. 08.12.2021.
