- b. at its discretion terminate the probation of a probationer and discharge him from the service."

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Aditya Kumar is hereby accepted and is discharged from the Government service w.e.f. 06.11.2023 on his own request.
