Subject:-

Implementing various schemes for Macdamization programme undertaken under "Cities and Towns Programme" and under various schemes like NABARD, PMGSY, CRF for seeking performance of other functions like berms Profile correction and Geometrics etc-Advisory regarding.

It has to be ensured at the level of Chief Engineers, Superintending Engineers & Executive Engineers as well, that the conditions of the bidding document are not compromised at any stage of execution. This takes reference to one important condition laid down in the bidding document, whereby it has to be ascertained that while carrying out macdamization work under different programmes like Cities & Town Programme, NABARD, PMGSY CRF & other schemes, the contractor simultaneously carries out other functions like road berms, prescribed camber, geometrics, profile corrections, road safety measures and accomplishes these allied activities as per approved design to the entire satisfaction of Engineer in-charge. This vital aspect shall have to be verified/taken into account by exercising due care & caution by the officers at the helm.

There are instances where it has been found on ground by the monitoring/verifying agencies that, although embedded in the agreement/contract, in certain cases these item/components were either deferred or executed with poor specifications which invites avoidable Public criticism.

In view of above, all the Chief Engineers, Superintending Engineers and Executive Engineers in-charge of these projects are placed on instructions to take due notice/cognizance of these provisions for compliance, so as to remain insulated from any breach of law that may result in unsavory consequences.

For prudence, important procedures and events related to these works shall be properly documented and documents/ photographs so prepared shall be maintained properly for future reference evidence.
