

Subject:- Select list of the candidates for the post of "Junior Engineer (Mechanical)" Public Works Department State Cadre in pursuance to Advertisement Notification of 2014 dated 02 of 2014 under item No.002 and 135.

Reference: Order No.175-SSB of 2017 dated 26.04.2017 issued by Service Selection, Board, J&K, Srinagar under endorsement No.SSB/Sel/Secy/2017/4470-72 Dated 26.04.2017.

Whereas, 46 number of vacancies of Junior Engineer(Mech) under OM category were referred to SSB vide this departments' letter No.PW(R&B) HRM/45/2014 dated 12.12.2014.

Whereas against the 46 posts of Junior Engineers (Mech) under OM category 45 candidates out of select list were recommended by SSB vide their letter No.SSB/Sel/2016/7697-7703 dated 31.03.2016 and stands appointed as Junior Engineers(Mech) in various Government Orders by the department from time to time, thus, leaving the balance of one unfilled post of J.E(Mech) under OM category.

Whereas, Slot No.30 under OM category was kept blank by the SSB in the main list owing to the fact that the candidate namely Shri Pardeep Singh S/O Ajeet Singh making grade at the appropriate place has done M.Tech degree from Punjab Technical University and as per the result cum details marks card, the candidate has completed M.Tech(Production Engineering) through part time on 06.07.2015 after cut off date of notification No.02 of 2014 i.e 06.02.2015.

Whereas the said candidate also reportedly, did not mention his qualification as M.Tech in the online application from.

Whereas the matter was discussed in the meeting of Board held on 11.04.2017 and Board noted that the candidate was not possessing

M.Tech on the cut off date i.e 06.02.2015 and 05 points accrued due to M.Tech degree shall be deducted from the overall merit of the candidate.

Whereas, on the above grounds, 05 points of M.Tech degree are deducted from the overall merit of the candidate and after deduction the candidate namely Shri Pardeep Singh S/O Ajeet Singh moves out from the selection zone as well as waiting list.

Whereas, subsequently the candidate earlier figuring at S.No.31 under OM category shall now figure at S.No.30 so on and so forth upto S.No.46 and candidate Shri Asif Rafiq S/O Sheikh Rafiq figuring at S.No.01 under OM category (waiting list) under Item No.135 shall enter into the selection zone at S.No.46 from the main select list.

Now, in view of above circumstances, sanction is hereby accorded to the temporary appointment of Asif Rafiq S/O Sheikh Rafiq R/O And Masjid Khanyar, Srinagar figuring at S.No.01 under OM category(waiting list) under item No.135 in main list No.SSB/Sel/2016/7697-7703 dated 31.03.2016 as Junior Engineer(Mechanical) State Cadre in the PB-2 of Rs.9300-34800 with Grade pay of Rs.4200.

The appointee shall be on probation for a period of two years and shall be allowed to join only on the production of the following certificates/documents in original:-

- i. Education/Technical Qualification certificates/marks sheet, which will also include whethe3r technical degree/diploma is approved for employment in J&K
- ii. Date of birth certificate /Matriculation certificate.
- iii. Permanent Resident Certificate/State Subject.
- iv. Age and Health Certificate issued by an Officer not below the rank of Chief Medical Officer.
- v. Character/antecedent Certificate.
- vi. Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- vii. Reserved category certificate, wherever required.
- viii. Any other relevant certificate as required under rules.

The above appointment shall be valid subject to inspection and verification of all certificates in original.

It shall be the responsibility of the Chief Engineer, Mechanical Engineering Department Kashmir to ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities and establish the genuineness of Qualification/Category Certificate/PRC/Domicile Status of concerned district for a period not less than 15 years (except Schedule Caste Category).

If at any state, it comes to fore that the any of the certificates are fake or that the qualification received is from a non recognized institute/university, the appointment shall deemed to be void ab initio and cancelled.

Further, the appointee shall execute a bond and produce it before the Chief Engineer, Mechanical Engineering Department, Kashmir before joining in the department in terms of the instructions of the General Administration Department issued vide Government Order - No1328-GAD of 2016 dated 07-12-2016.

The appointee shall report to the Chief Engineer, MED, Kashmir within 21 days from the date of issuance of this order.
