**Government Order No: 193- PW(R&B) of 2017
Dated: 08.06.2017**

Whereas, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer Grade- II, Diploma Holder after acquiring Section (A&B) shall be treated as degree holder for the purpose of seniority from the date of completion/passing of AMIE section (A&B) Course;
