On the basis of recommendations of J&K Service Selection Board, sanction is hereby accorded to the temporary appointment of following candidates against the posts of Draftsman (Mechanical) Public Works (R&B) Department (State Cadre) in the PB-2 of Rs.5200-20200 with Grade pay of Rs.2400/-. The appointee s shall be on probation for a period of two (02) years:

The appointees hailing from Jammu Division shall report to Chief Engineer, MED, Jammu and the candidates hailing from Kashmir Division shall report to Chief Engineer, MED, Kashmir.

The appointees shall be allowed to join only on the production and verification of following documents /certificates in original:-

- i) Educational/Technical qualification certificate/marks sheet, which also include the authenticity of technical degree/diploma which is approved for employment in J&K State.
- ii) Date of birth certificate/Matriculation certificate.
- iii) Permanent Resident Certificate/State Subject.
- iv) Age and health certificate issued by an officer not below the rank of Chief Medical Officer.
- v) Character/antecedents certificate.
- vi) Certificate from concerned authorities to the effect that no loan under self employment scheme has been obtained/availed by the concerned candidate.
- vii) Reserved category certificate, wherever required.

viii) Any other relevant certificates as required under rules.

The above appointment shall be valid subject to the inspection and verification of all certificates in original.

It shall be the responsibility of the Chief Engineer, MED, Jammu/Kashmir to ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities and establish the genuineness of Qualification/Category Certificate/PRC/Domicile status of concerned District for a period not less than 15 years except Schedule Caste Category.

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification received is from a non-recognized institute/university, the appointment shall be deemed to be void ab-initio and cancelled.

The above mentioned appointees must necessarily report to the concerned Chief Engineers within a period of 21 days from the date of issuance of this Order and their posting orders shall be issued separately after receipt of their joining reports from the concerned HODs.
