Subject:- Appointment of Draftsman (Civil) PW(R&B) Department (Divisional Cadre, Jammu).

Reference: J&K Services Selection Board, Jammu order No. 1393-SSB of 2016 dated 21.12.2016.

WHEREAS, J&K Services Selection vide letters No. SSB/Secy/Sel/2016/16120 -26 dated 09.06.2016 has forwarded the select list of 41 candidates for appointment to the post of Draftsman (Civil) (**Divisional Cadre Jammu**) in the Public Works (R&B) Department; and

WHEREAS, on the basis of recommendations made by J&K SSB, appointment orders in favour of the recommended candidates have been issued vide Government Order No. 214-PW(R&B) of 2016 dated 04.07.2016 ; and

WHEREAS, among other condition, the aforementioned government orders dated 4.7.2016, specifically provided that the appointees shall report to the Chief Engineers, PW(R&B) Jammu within a period of 21 days from the date of issuance of the order; and

WHEREAS, the 06 candidates from Jammu Division appointed as Draftsman (Civil) (**Divisional Cadre Jammu**) in Public Works (R&B) Department vide aforementioned Government orders have failed to submit their joining report within the stipulated/prescribed period; and

WHEREAS, the appointment has been cancelled in favour of (06) candidates who have failed to join the Department within the stipulated time after completing the codal formalities vide Govt. Order No. 66-PW(R&B) of 2017 dated 22.02.2017; and

WHEREAS, the Department was operating the waiting lists under OM & RBA categories and the appointments was made vide Govt. order No. 118-PW(R&B) of 2017 dated 29.03.2017 and 165-PW(R&B) of 2017 dated 17.05.2017 ; and

WHEREAS, the Service Selection Board vide order No. 1393-SSB of 2016 dated 21.12.2016 has cancelled the selection of Mr. Ather Nawaz Khan S/O Raja Mohd Khan whose selection was recommended under the RBA category in the main select list at Sr. No. 01, but his recommendation was kept withheld due to the non-production of his documents and pursuing of higher studies; and

WHEREAS, Mr. Asif Iqbal Qazi S/O Mohd. Iqbal Qazi, whose name of figures at S.No. 02 in the waiting list under the RBA category, represented to the competent authority for considering his appointment against the said vacancy.


WHEREAS, Mr. Azhar Ud din S/O Najam Ud Din at Sr. No 01 of the waiting list under RBA category was already appointed as Draftsman vide aforementioned government order against the dropout vacancy; and

WHEREAS, the competent authority has approved the appointment of the candidate; and

NOW THEREFORE, in light of above facts, sanction is hereby ordered for the temporary appointment of Mr. Asif Iqbal Qazi S/O Mohd. Iqbal Qazi R/O Chinyas Doda under RBA category as Draftsman (Civil) Divisional Cadre Jammu in the PB-2 of Rs. 5200-20200 with Grade pay of Rs. 2400/- by operating the waiting list. The appointee shall be on probation for a period of two years and shall report to the Chief Engineers PW(R&B) Jammu.

The appointee shall be allowed to join only on the production of original and verification of the following certificate/documents:-

- (i) Education/Technical qualification certificates/marks sheet, which will also include whether technical degree/diploma is approved for employment in J&K.
- (ii) Date of birth/Matriculation certificate.
- (iii) Permanent Resident Certificate/State subject.
- (iv) Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- (v) Character/antecedent Certificate.

- (vi) Certificate from the concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- (vii) Reserved category certificate, wherever required.
- (viii) Any other relevant certificates as required under rules.

It shall be the responsibility of the Chief Engineer, PW(R&B) Department Jammu to ensure that all the certificates shall be got inspected in original and subsequently get verified duly and diligently from the relevant issuing authorities and that the genuineness of qualification/category certificates/PRC/domicile status of concerned District as verified/established for period not less than 15 years (except schedule caste).

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification received is from a non-recognized institute/university, the appointment shall be deemed void ab-initio.

Further, the appointment of above candidate is provisional and subject to the following conditions:-

- (i) In case of receipt of an adverse report about character and antecedents from Additional Director, General of Police, CID, Jammu and Kashmir and on confirmation thereof by the State/Divisional/District Level Screening Committee, as the case may be the appointment shall automatically stand cancelled without any notice.
- (ii) A person convicted by the competent court of an offence involving moral turpitude, heinous offences like murder, rape, dacoity, robbery and offences under NDPS Act shall be regarded not fit for govt. service.
- (iii) During course of verifications of qualification, certificates, documents or any other relevant documents on the basis of which candidates have been appointed turns out to be fake/factious; the appointment shall be deemed to be cancelled ab-initio.
- (iv) Salary of the appointee shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificates/documents is received from the concerned authorities.

- (v) The inter se seniority of the candidate shall be fixed separately.
- (vi) The appointment of the candidates as "Draftsman" Shall be subject out of the writ petition(s) pending in any court of law.
- (vii) The above arrangement is purely for joining purpose and the formal adjustment/posting order of the selectee shall be issued subsequently.
- (viii) The appointment shall be governed as per SRO-400 dated 24.12.2009(NPS).


