In continuation to the Government order No. 343-PW(R&B) of 2016 dated 10.11.2016, sanction is hereby accorded to the temporary appointment of the following three (03) candidates as Junior Engineer (Civil) Public Works (R&B) Department (State Cadre) in the PB-2 of Rs.9300-34800 with Grade Pay of Rs.4200/.

The appointees shall be on probation for a period of two years and shall be allowed to join only on the production of the following certificates/documents in original:-

i. Education/Technical Qualification certificates/marks sheet, which will also include whether technical degree/diploma is approved for

employment in J&K.

- Date of birth certificate/Matriculation certificate.
- iii. Permanent Resident Certificate/State Subject.
 - Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.

- Character/antecedent certificate.
- vi. Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- vii. Reserved category certificate, wherever required.
- viii. Any other relevant certificates as required under rules.

It shall be the responsibility of the Chief Engineer, PW(R&B) Department Jammu/Kashmir to ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities .

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification received is from a non recognized institute/university, the appointment shall be deemed to be void ab initio and cancelled.

Further, the appointment shall be provisional and subject to the following conditions:

- i. That in case of any adverse report about his character and antecedents is received from Additional Director, General of Police, CID, Jammu and Kashmir (to Whom a reference shall be made by the authority), the candidate shall have no right to claim his/her appointment as Junior Engineer and their appointment as such shall be deemed to be void ab-initio and cancelled as such.
- ii. Salary of these appointees shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP,CID J&K and verification of relevant certificate/documents is received from the concerned authorities.
- iii. The inter-se seniority of these appointees shall be fixed separately.
- iii. The appointment of the candidates as Junior Engineer (Civil) shall be subject to outcome of writ petition(s) pending if any, in any court of law.
- iv. Appointment shall be governed as per SRO 400 dated 24.12.2009 (NPS).
- v. The above arrangement are purely for joining purpose and the formal adjustment/posting order of the selectees shall be issued subsequently.

The appointees shall report to the concerned Chief Engineers, PW(R&B) Department, Jammu/Kashmir within 21 days from the date of issuance of this order.
