Sanction is hereby accorded to the temporary appointment of following candidates as Assistant Engineer (Civil) in the PB-2 9300-34800 with Grade Pay Rs.5400 in the Public Works (R&B) Department:

1. Mr.Sachin Sharma S/o Satya Prakash Sharma R/O House No.22, Lane No.2, Sunder Nagar, Talab Tillo, Jammu figuring at Sr. No.1 of the waiting list under Notification No.18-PSC (DR-P) of 2013 dated 15-10-2013 having merit position 59.99.
2. Mr.Kanav Mahajan S/o Anil Gupta R/o Plot No.197, Rehari Colony, Jammu figuring at Sr.No.1 of the waiing list under Notification No.01-PSC (DR-P) of 2015 dated 05-01-2015 having merit position 58.96

The appointees shall be on probation for a period of two years and shall be allowed to join only on the production of the following certificates/documents in original.

- i. Education/Technical Qualification certificates/mark sheet, which will also include whether technical degree/diploma is approved for employment in J&K.
- ii. Date of birth certificate/Matriculation certificate.
- iii. Permanent Resident Certificate/State Subject.
- iv. Age and Health Certificate issued by an officer not below the rank of Chief Medical Officer.
- v. Character/antecedent certificate.
- vi. Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- vii. Reserved category certificate.
- viii. Any other relevant certificates as required under rules.

It shall be the responsibility of respective Chief Engineer to ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities.

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification received is from a non recognized institute/university, the appointment shall be deemed to be void ab initio and cancelled.

Further, the appointment shall be provisional and subject to the following conditions:

- i. that in case of any adverse report about their character and antecedents is received from Additional Director, General of Police, CID, Jammu and Kashmir, (to whom a reference shall be made by the authority), the candidates shall have no right to claim their appointment as Assistant Engineer and their appointment as such shall be deemed to be void ab-initio and cancelled as such.
- ii. salary of the appointees shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP,CID J&K and verification of relevant certificate/documents is received from the concerned authorities.
- iii. the inter se seniority of the appointees shall be fixed separately.
- iv. the appointment of the candidates as Assistant Engineer shall be subject to outcome of writ petition(s), if any, pending in any court of law.
- v. appointment shall be governed as per SRO 400 dated 24-12-2009(NPS)

The appointees shall report to Chief Engineer, PW(R&B) Jammu within 21 days from the date of issuance of this order.
