On the basis of recommendations of J&K Services Selection Board, sanction is hereby accorded to the temporary appointment of the following two (02) candidates as Junior Engineer (Civil) Public Works (R&B) Department (State Cadre) in the PB-2 of Rs.9300-34800 with Grade Pay of Rs.4200/.

The appointees shall be on probation for a period of two years and shall be allowed to join only on the production of the following certificates/documents in original:-

- Education/Technical Qualification certificates/marks sheet, which will also include whether technical degree/diploma is approved for employment in J&K.
- Date of birth certificate/Matriculation certificate.
- Permanent Resident Certificate/State Subject.
- Age and Health Certificate issued by an Officer not below the rank of Chief Medical Officer
- Character/antecedent certificates.
- Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidates.
- Reserved category certificate, wherever required.
- Any other relevant certificates as required under rules.

- ix. Verification regarding recognition of Institute from the concerning issuing authority as well as verification that the Institute/agency issuing any of the above is indeed competent.

It shall be the responsibility of the Chief Engineer, PW(R&B) Department Jammu to ensure that all the certificates are got inspected in original and subsequently got verified duly and diligently from the relevant issuing authorities.

If at any later stage, it comes to fore that any of the certificates are fake or that the qualification received is from a non recognized Institute/University, the appointment shall be deemed to be void ab initio and cancelled.

Further, the appointment shall be provisional and subject to the following conditions:

- ii. Each appointee shall give an undertaking in the shape of an affidavit that in case if any adverse report about his character and antecedents is received from Additional Director, General of Police, CID, Jammu and Kashmir (to whom a reference shall be made by the Chief Engineer), the candidate shall have no right to claim his/her appointment as Junior Engineer and their appointment as such shall be deemed to be void ab-initio and cancelled as such.
- iii. Salary of these appointees shall not be drawn and disbursed unless satisfactory character and antecedents report is received from ADGP, CID J&K and verification of relevant certificate/documents is received from the concerned authorities.
- iii. The inter-se seniority of these appointees shall be fixed separately.
- iv. The appointment of the candidates as Junior Engineer (Civil) shall be subject to outcome of writ petition(s) pending if any, in any court of law.
- v. Appointment shall be governed as per SRO 400 dated 24.12.2009 (NPS).
- vi. The above arrangements are purely for joining purpose and the formal adjustment/posting order of the selectees shall be issued subsequently.

The appointees shall report to the concerned Chief Engineers, PW(R&B) Department, Jammu within 21 days from the date of issuance of this order.


