Whereas, the department has received the case of Ms.Mariya Ashraf Khan, Junior Engineer (Civil) for acceptance of her degree and inclusion of her name at appropriate place in the seniority list of Junior Engineers (Civil) degree holders, whose particulars are given as under:-

Whereas, the case was examined in the department and the Degree/ marks certificates of the Engineer were forwarded to the Controller of Examination, University of Kashmir vide this department's letter dated 02.09.2022 for verification/ authentication of genuineness of the Degree acquired by the said Engineer. In response the Assistant Controller of Examination, University of Kashmir vide communication No. F(Result-Verf./ Tab/ KU/ 22/ 289 dated 20.09.2022 has furnished the verification of the degree certificate acquired by her.

Whereas, the above named Junior Engineer has also produced undertaking in the shape of Affidavit dully attested by the 1st Class Magistrate, affirming therein that in case the



information about her degree is found bogus at any point of time her degree shall be deemed cancelled ab-initio action as warranted under rules shall be initiated against him in the light of J&K Civil Services (Classification, Control and Appeal) rules, 1956.

Whereas, on further examining of the case, it has been observed that there is a case to accept her Degree from the date of passing of his Degree and include her name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers (Civil) as and when the same is notified afresh by the department and also exclusion of her name from the seniority list of Diploma holders Junior Engineers (Civil).

Now, therefore, before acceptance of the Degree acquired by the above named Junior Engineer (Civil) and also inclusion of her name at appropriate place in the seniority list of Degree holders Junior Engineers (Civil), objections are invited from the members of the cadre who are likely to be affected due to decision of the department which should reach in the Administrative Department through concerned Chief Engineer/s by Post or by e-mail to compwd@rediffmail.com within a period of 21 days from the date of issuance/ publication of the notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
