Whereas, the above named incumbent has also produced undertakings in the shape of Affidavit dully attested by the Executive Magistrate 1st Class affirming therein that in case the degree submitted by him is found fake or forged at any time during service, he shall be personally responsible and action as warranted under relevant rules shall be taken against him without any notice.

Whereas, on further examining of the case, it has been observed that there is a case to accept his Degree from the date of passing of his Degree and include his name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers (Civil) as and when the same are notified afresh and also exclusion of his name from the relevant seniority list of Junior Engineers Diploma holders (Civil).

Now, therefore, before acceptance of the Degree acquired by the above named Junior Engineer and also inclusion of his name at appropriate place in the seniority list of Degree holders Junior Engineers (Civil), objections are invited from the members of the cadre who are likely to be affected due to decision of the department which should reach in the Administrative Department through concerned Chief Engineer/s by Post or by e-mail to compwd@rediffmail.com within a period of 21 days from the date of issuance/ publication of the notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
