Whereas, after examination of the case the Degree/ marks certificates of the above named Engineer were forwarded to the concerned University vide this department's letter dated 26/12/2022 for verification /authentication and genuineness of the Degree acquired by the said Engineer. In response the concerned University vide their communication No. EEA/ EX/



VRFC/ 204/230200017360 dated 03.05.2023 has verified/ confirmed the degree certificate acquired by the concerned candidate.

Whereas, as per Schedule-II "A" of J&K Engineering Subordinate Service Recruitment rules 1997, notified vide SRO-180 dated 26.05.1997, the Degree/ Section A&B from AMIE is recognized. Besides, relevant extract of clarification on the subject received from AICTE vide their communication dated 17.03.2021 is given as under:-

Whereas, the Director, (EE&A), The Institution of Engineers (India), Kolkata vide communication dated 03.05.2023 has confirmed that "Mr.Manjeet Singh (ST- 605978-9) has passed Section-A (Diploma) in Summer 2014 (Roll No.308860) and Section B in Winter 2020 (Roll No.552512) in Civil Engineering. He was enrolled as Senior Technician (ST-605978-9) on 25.01.2013. Presently he is an Associate Member (AM-301362-9) since 11.02.2022."

has named Junior Engineer above the Whereas. shape Affidavit dully undertaking in the of produced attested by the 1st Class Magistrate affirming therein that, in case information submitted by him about his degree is found fraudulent/bogus at any time during service, the same shall be deemed to be cancelled ab- initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

Whereas, on further examination of the case, it has been observed that there is a case to accept his Degree from the date of passing of his Degree and include his name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers Civil as and when the same are notified afresh and also exclusion of his name from the relevant seniority list of Junior Engineers Diploma holders (Civil).

Now, therefore, before acceptance of the Degree acquired by the above named Junior Engineer and also inclusion of his name at appropriate place in the relevant seniority list of Degree holders Junior Engineers (Civil), objections are invited from the members of the cadre who are likely to be affected due to decision of the department which should reach in the Administrative Department through concerned Chief Engineer/s /by Post or e-mail to compwd@rediffmail.com within a period of 21 days from the date of issuance/ publication of the notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
