Whereas, the above named incumbent has also produced undertakings affirming therein that in case, the information suppressed by him is found fraudulent/bogus/ fictitious/ tempered at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K CCA Rules 1956.

Whereas, on further examining of the case, it has been observed that there is a case to accept his Degree from the date of passing of his Degree and include his name at appropriate place in the relevant seniority list of Degree Holders Junior Engineers (Civil) as and when the same are notified afresh and also exclusion of his name from the relevant seniority list of Junior Engineers Diploma holders (Civil).

Now, therefore, before acceptance of the Degree acquired by the above named Junior Engineer and also inclusion of his name at appropriate place

in the relevant seniority list of Degree holders Junior Engineers (Civil), objections are invited from the members of the cadre who are likely to be affected due to decision of the department which should reach in the Administrative Department through concerned Chief Engineer/s by Post or by e-mail to compwd@rediffmail.com within a period of 21 days from the date of issuance/ publication of this notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
