Whereas, the above incumbent has also produced undertaking affirming therein that if the information regarding Degree is found fake at any point

of time in his service, in that case the Degree shall be deemed to be cancelled abinitio and action as warranted under rules shall be initiated against him in light of the J&K Civil Services (Classification, Control and Appeal) Rules 1956.

Whereas, during examination of the case, it has been observed that there is a case to accept his Degree from the date of passing and include his name at appropriate place in the relevant seniority lists of JE (Civil) Degree Holders as and when the same is notified afresh by the department.

Now, therefore before acceptance of the Degree in Civil Engineering acquired by Mr. Sourabh Sangral, JE (Civil) and subsequent inclusion of his name at appropriate place in the relevant seniority lists, objections are invited from the members of the cadre who are likely to be affected due to decision of the department which should reach in the Administrative Department through concerned Chief Engineer by Post or by e-mail to compwd@rediffmail.com within a period of 21 days from the date of issuance/ publication of the notice. No claim, whatsoever, shall be entertained after expiry of stipulated time period.
