The appointees shall be on probation for a period of two years and shall be allowed to join only on production of the following certificates/documents in original.

i) Education/Technical Qualification certificates/marks sheet, which will also include whether technical degree/diploma is approved for employment in J&K.

ii) Date of birth certificate/Matriculation certificate.

iii) Permanent Resident Certificate/State Subject

- iv) Age and Health Certificate issued by an officer not below the rank of Chief Medical Office.
- v) Character/antecedent certificate
- vi) Certificate from concerned authorities to the effect that no loan under self-employment scheme has been obtained/availed by the concerned candidate.
- vii) Reserved category certificate, wherever required.

viii) Any other relevant certificate as required under rules.

ix) Verification of genuiness of qualification, Handicapped, reserved

category certificates

x) Verification regarding recognition of institute from the concerning issuing authority a well as verification that the institute/agency issuing any of the above certificates is indeed competent to do so!

However, the above appointment is provisional and subject to the following conditions:-

- (i) The appointee shall give an undertaking in the shape of an affidavit to the effect that in case any adverse report about his/her character and antecedents is received from Additional Director General of Police, CID, Jammu and Kashmir to whom a reference shall be made by the authority to whom they will submit their joining report or any other adverse report, the candicates shall have no right to claim their appointment as Junior Assistants and their appointment as such shall be deemed to be void, ab-initio and cancelled as such.
- (ii) If on verification, the certificates produced by the appointees are proved fake or forged, the appointment shall be cancelled abinitio.
- (iii) Salalry of the appointees shall not be drawn and disbursed to them unless satisfactory character and antecedents report is received from ADGP, CID J&K viz-a-viz the verification of relevant certificate/documents.

(iv) The appointment order shall be governed under new pension

scheme as per SRO-400 dated 24.12.2009.

(v) The inter-se seniority of the candidates/appointees shall be as per standing rules as on date.
