# Government Order No. 23 PW(R&B) – 2018 Dated: 12-01.2018

Whereas, in pursuance of Rule 24(I) of Classification Control and Appeal Rules of 1956, the seniority of members of Mechanical Wing of J&K PW(R&B) Gazetted Service needs to be determined accordingly from the  $\mathbf{1}^{\text{st}}$  month of calendar year in an updated manner.

Whereas, the final seniority list of AE (Mech) J&K Gazetted Service PW(R&B) Department issued vide G.O. No. 64 of Works dated 12.02.2002 which has been exhausted as most of the members have either retired or confirmed at higher levels.

Whereas, vide Govt. Order No. 132-PW(R&B) of 2005 dated 05.04.200, vide Government Order No. 1517-GAD of 2006 dated 13.12.2006 and vide Govt Order No. 65 – PW(R&B) of 2007 dated 01.03.2007, one hundred four (104) A.E Mechanical including direct quota of 29 i.e. (77 degree holders and 27 diploma holders) respectively are working against substantive posts (Annexure A & B).

Whereas, above confirmed AEs (Mech) have been placed as In-charge AEE Mech through various Govt. Orders from time to time and these in-charge AEEs have not been regularized through DPC/PSC till date.

Whereas most of the Officers placed upto the level of I/c Executive Engineers (Mechanical) are yet to be confirmed at lower level posts.

Whereas, the Department is contemplating to update seniority list of AE Mech working against substantive posts for getting services of those Officers regularized who have been placed as Incharge AEE ( Mechanical); and

Therefore, Tentative Seniority list on the basis of available records is hereby issued, inviting objections for correction /feedback, if any, for enlistment in the same list from the members of J&K Gazetted Service of Mechanical. Objections, if any, shall

be forwarded with all supporting documents through the Chief Engineer Mechanical Engineering Department Jammu / Kashmir / SE (Mech) (HQ Kargil), within twenty-one days from the issuance of this Government Order.

The tentative seniority list is subject to the;-

- (a) Outcome of the writ petitions/pending case(s) in the competent court of law.
- (b) superior claim of the Officers placed as AE (Mech) before the Officers mentioned in the Annexure (A & B)
- (c) Actual Date of births of the Officers as per verification from service book / Matriculation certificate.
